INFORMATION WE COLLECT

Personal Information

When you register on our site, we collect personal information such as:

- Name
- Email address
- City/Town (if provided)
- Country (if provided)
- License information
 - State License Number
 - State Where Licensed
 - License Type
 - National Certification Number

Non-Personal Information

We may collect non-personal information about users whenever they interact with our site. Non-personal information may include:

- Browser name and version
- Type of device used
- Technical information about users' means of connection to our site, such as the operating system and Internet service provider
- IP address and general geographic location
- Site usage statistics through cookies and analytics tools

HOW WE USE YOUR INFORMATION

The information we collect from you may be used in the following ways:

- **To administer training content.**
- **To send periodic emails:** The email address you provide may be used to send you information, respond to inquiries, and/or other requests or questions.
- **To report training data to an accrediting agency.**

HOW WE PROTECT YOUR INFORMATION

We adopt appropriate data collection, storage, and processing practices and security measures to protect against unauthorized access, alteration, disclosure, or destruction of your personal

information, username, password, transaction information, and data stored on our site.

- Data is encrypted using industry-standard security protocols.
- Sensitive information is transmitted using Secure Socket Layer (SSL) technology.
- Access to personal data is restricted to authorized personnel only.
- Regular security audits and vulnerability assessments are conducted.

However, please note that no method of transmission over the Internet or method of electronic storage is 100% secure, and we cannot guarantee its absolute security.

COOKIES AND TRACKING TECHNOLOGIES

Types of Cookies We Use
